Government on the following conditions:-

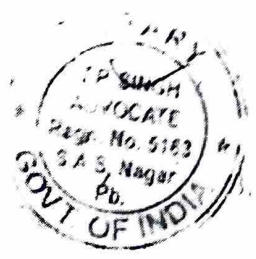
1. In future at the time of inspection Or complaint , if it is observed that nay
wrong information has been provided at the time of obtaining no
objection certificate or if the instructions issued by the State
Government are not complied with or the written conditions given in the
affidavit are not complied with the in such conditions, the No Objection
Certificate can be withdrawn at any time
2. In your school Punjabi would be taugther compulsory upto the Tenth
level and C.B.S.E. New Delhi shall surely make arrangement to take
examination of Punjabi and with this it is also informed that in the event
of not doing this , the No Objection Certificate shall be withdrawn with
immediate effect.

The school management shall comply with the the Notification issued by
the Punjab Government under the R.T.E. Act 2009 and the rules of
R.T.E. Act -2009 for Punjab State in letter and spirit.

After obtaining the affiliation of the C.B.S.E. New Delhi, the
management of the school shall be bound to pay the salary and other
allowances etc. through accounts payee cheques to the teaching and non
teaching staff of the school. The school at the time of extension/
upgradation according to the government instructions, shall deposit, the

required reserve fund of teaching & non-teaching staff . In the event of not doing so, the no objection certificate shall immediately be withdrawn.

8. You and your management shall ensure it that whenever any sort of information is demanded by the Education Officer of your district or any senior officer of the Education Department, then the required information shall be provided to him and simultaneously cooperation shall be given. In the event of not doing so, no objection certificate shall immediately be withdrawn.
6. The inspection of the conditions of the Security of the children, public health sanitation and others no objection certificates shall be done by the authorities of the Punjab Government authorities from time to time.
7. The compliance of the guidelines issued by the Punjab Government vide letter No.2/93/2009/3SE3/1360154 dated 26.11.2018 be made in letter and spirit.
