- 5) The renewal of the Society registration, if may be necessary, the same shall be ensured.

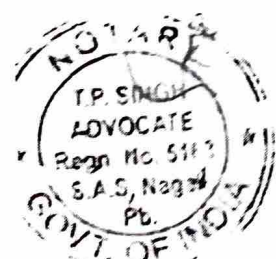
The school is not being run for the benefit of any person, gathering or personal-gatherings or for any other personal benefit.

- 7) The accounts of the school be audited by any Chartered Account and approved and required statements shall be prepared according to the rules.
- 8) The school in the first class 25% out of the total number, shall admit economical weaker section and without facility group and free and compulsory education, shall given upto its completion. If the school provides pre-primary education, the same conditions shall be applicable.
- 9) For the children shown in para 7, of Section 12 of the Act provision 2, school shall bear the expenses. For obtaining this, the school shall have to maintain a separate Bank-account.
- 10) The school shall not charge any capitation fee and shall not be show any discrimination to the child or his parents or his guardian.
- 11) The school shall not deny to give admission due to any of the following reasons:-
- Non production of the age proof of any child.
  - Any of the child demanding admission in the extended period or after the extended period.
  - Due to any of reason of Religion, Caste, Race of Birth place or any of these reasons.

12. This shall be ensured in the school that:-

- Any of the admitted child shall not be detained in the class or terminated before the completion of the basic education.
- No child shall be given corporate punishment or mental harrasment.
- The child shall not be required to pass any examination of the Board upto completing the initial education.
- According to the clauses of the act, the handicap children with special needs should be encouraged.
- Every child completing the initial education shall be provided certificate under rule 21.
- According to the provisions of subrule(1) of Section of 23 teachers fulfilling minimum educational qualifications shall only be appointed.
- The teachers shall not indulge in any private teching activity.

The school shall adopt the subjects prescribed by the appropriate Authority.

Shall comply with the terms and conditions shown under Section 19 of the School Act.

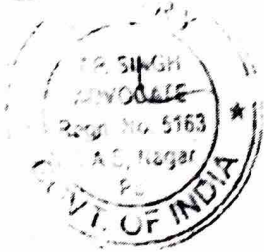
